2. These plans have already been circulated to all the relevant departments. A final copy is again being circulated to the departments for their comments and feedback.

3. In this connection, NGT in OA No. 606/2018 has directed the Chief Secretary to appear before the tribunal on 07.03.2019 along with progress report and action taken on various directions of NGT. Chief Secretary has desired that time bound Action Plan accepted by the concerned department for compliance of NGT orders be finalized by 21.02.2019.

It is accordingly requested that the Action Plans prepared by the Department of Environment for control of Air Pollution, River Pollution and Waste Management may kindly be scrutinized particularly the timelines. Feedback/Changes, if any, be intimated without any further delay failing which it may be presumed that the Department has accepted the timelines and other details mentioned in the Action Plans
