1. The Committee reviewed the progress of various activities relating to Solid Waste Management as per agenda and following observations/ directions were issued:

- 2. The Committee decided that it would like to visit notified cities/ towns for ground analysis and consultations on the plans being prepared by DLG for solid waste management.
- 3. The Committee further directed that the Department of Local Government shall plan and undertake measures for optimal utilization of the areas under flyovers at Zirakpur, which are highly prone of littering and dumping of waste.
- 4. The Committee directed the Department of Rural Development to issue notification of 3 villages in each district to be developed as model villages in compliance of NGT orders. They may preferably be census towns.
