- 9) Punjab State Power Corporation Limited, Amritsar.
- 10) Punjab Pollution Control Board, Amritsar.
- 11) National Highway Authority India, Jalandhar (For Amritsar).
- 12) Improvement Trust, Amritsar.


It is further intimated that the progress of tasks is to be submitted to Central Pollution Control Board in every six month.


