Minutes of 4<sup>th</sup> meeting of AQMC held under the Chairmanship of Deputy Commissioner, SAS Nagar on 06.08.2019 at 11:15 A.M at Committee Room, SAS Nagar regarding discussion of action points of the draft action plan for control air pollution of Derabassi town with the Stakeholder Departments.

At the outset, the Environmental Engineer, PPCB informed that Derabassi town has been declared as non attainment town as the ambient air quality as not conforming to the prescribed standards in respect of  $PM_{10}$ . Further, the participants were made aware regarding the Directions passed by the Hon'ble NGT in OA no. 681 of 2018 on 8.10.2018. It was brought out that the draft Action Plan has been prepared by the Directorate of Environment and Climate Change in consultation with Punjab Pollution Control Board.

Subsequently, the department wise progress/ follow-up action for compliance of the decisions of the second meeting was discussed in detail and the discussions held in the meeting are delineated as under:
