- 3. Separate meetings with DLG be conducted to discuss & prepare the strategy for strict compliance by BWGs and to discuss and prepare the road map for reaching out to form at least one model city / town pertaining to the solid waste management.
- 4. DECC to revise the Action Plans for Waste Management for six types of Waste in light of latest Orders of Hon'ble NGT and updated summary sheets.
