(i) The Committee noted the progress w.r.t Status of Ambient Air Quality and installation of CAAQMSs in all the Nine NACs.

## Agenda No. 10.4 Review of Activities pertaining to Punjab Pollution Control Board.

### 1. CIE-1: Conversion of Induction Furnaces (IFs) to Side Suction Hood

(i) The Committee directed PPCB to provide the list of remaining 9 units to whom directions U/s 31-A of Air Act, 1981 issued for closure by 31.12.20.

## 2. CIE-2(i): Conversion of Industries from Coal to CNG/ PNG

(i) PPCB reported that the 928 units being converted from coal to CNG/PNG falls in Mandi Gobindgarh (226), Khanna (93), Ludhiana (520) and Amritsar (89). The work of laying of Gas pipeline in Khanna and Ludhiana is yet to

be started.

- (ii) It was further reported that the industries falling in Mandi Gobindgarh & Amritsar are to be converted to Gas by 31.03.2021.
- (iii) The Committee directed PPCB to submit the revised timelines along with milestones for the above cities.

#### 3. CIE-3: Conversion of Natural Draft Brick Kilns to Induced Draft

- (i) The Committee directed PPCB to initiate action against 02 units of Ludhiana and provide the list of remaining 09 units to whom directions U/s 31-A of Air Act, 1981 issued for closure by 31.12.20.
- (ii) PPCB was directed to provide the details of Environmental compensation recovered from Brick Kilns which have not converted to the Induced Draft upto 30.09.2019.

## 4. CIE-4: Action against Non-Complying (NC) Industrial units

- (i) The Committee directed PPCB to complete the action against pending 68 units by 31.03.2021.
- (ii) Committee directed the PPCB to impose Environmental Compensation (EC) instead of taking Performance Bank Guarantee (PBG) and a separate account shall be maintained for the same in compliance with the Govt. order dated 20.01.20.

#### 5. CIE-5: Shifting of industries from Non-Designated Area to Industrial Area

- (i) PPCB reported that the list of industries located in non-designated areas in the cities Jalandhar, Amritsar, Patiala, Khanna & Mandi Gobindgarh has been provided to Chief Town Planner (CTP), Punjab.
- (ii) The District Town Planner reported that the coordinates of the industries need to be provided by PPCB for taking further action.
- (iii) The Committee directed PPCB to provide the list of industries along with coordinates and also share the DPRs of Carrying Capacity & Source Apportionment Studies of all the NACs with CTP, Punjab by 31.01.21.

#### 6. CBGB-3: Control on the burning of agriculture waste and crop residue

- (i) The Committee noted the progress.
- (ii) The Committee directed PPCB to submit the compliance of Hon'ble NGT order dated 21.08.20 in O.A. No. 681/2018 w.r.t action taken for control of stubble burning as on 31.12.20 to CPCB by 15.01.21 with copy to DECC.

#### 7. COS-1: Dissemination of Air Quality Index.

Proceedings of 10<sup>th</sup> AQMC held on 09.12.2020

(i) The Committee directed PPCB to complete the tendering process of remaining 2 CAAQMS along with other 8 CAAQMS to comply with the orders of Hon'ble NGT dated 21.08.2020 to install the same by 20.02.2020. Further, the funds available under the Consent Mechanism/Environmental Compensation may be utilized for the procurement of the remaining 2 CAAQMS.

# 8. COS-2 & 3: Establish an Air Quality Management Division at SPCBHQ and helpline in each city as well as SPCBHQ

- (i) PPCB reported that Public Grievance Redressal Portal (PGRP) shall be commissioned by 31.12.2020.
- (ii) The Committee directed PPCB to submit the compliance of NGT order dated 21.08.2020 w.r.t number of complaints received on PGRP, steps taken for redressal and improvement achieved & planned as on 31.12.2020 to CPCB by 15.01.2021 with copy to DECC.

#### 9. COS-4: Monitoring of DG sets and action against violations

- (i) The Committee directed PPCB to complete the pending action against 18 units by 31.03.21.
- (ii) Committee directed the PPCB to impose Environmental Compensation (EC) instead of taking Performance Bank Guarantee (PBG) and a separate account shall be maintained for the same in compliance with the Govt. order dated 20.01.20.

## 10. COS-5: Carrying Capacity (CC) and Source Apportionment (SA) studies.

- (i) The Committee noted the slow progress with serious concern.
- (ii) The Committee directed PPCB to ensure the completion of Carrying Capacity and source apportionment studies of all the 9 NACs by 31.03.21.
- (iii) PPCB to share the draft of the above studies with CTP Punjab and its comments shall be included in the final reports.

(i) The Committee asked PPCB to provide the details of number of awareness programs organized, number of jingles broadcasted and number of advertisements published.

  - (c) The process of hiring of agency for noise mapping & identification of hotspots for metropolitan cities (Amritsar & Ludhiana) as directed by the CPCB vide letter dated 21.06.2019, shall be completed by 31.01.2021.
  - (d) PPCB to file the status of procurement of Noise Level Meters (NLMs) and applying compensation regime to CPCB as on 31.12.2020 in compliance of NGT order dated 21.08.2020 in O.A. No. 681/2018 with copy to DECC.
  - (e) The revised timelines to be submitted along with milestones for installation of Noise Limiters and procurement of Noise Level Meters for the State.

(i) Committee directed the Department to complete the pending work in Amritsar city by 31.03.21.

# 16. CVE -6(a): Widening of roads and infrastructure for decongestion of roads.

(i) The Committee directed the Department to initiate the activity in Jalandhar, Amritsar & Dera Bassi and submit the revised timelines along with mile stones.

#### 17. CVE-6(b): Road design improvement.

(i) Department reported that storm water sewer, RCC drains and underground telephone pipelines were laid under road design improvement to complete the work by 31.03.21.

- (iii) The Committee directed the Department to organize programs to create awareness for benefits of CNG autos/taxis.
